



Disclosure in terms of the Financial Advisory and Intermediary Services Act (FAIS)

6. **Should this transaction be confirmed by our registered representative, your premium will be R..... per month. In the first month only there is a once off Legal Services activation fee of R65 so your first debit will be R..... Please note that the debit reference for our premium will reflect as LEGAL&TAX on your bank statement.**

 - 10.3. Family Law - matters including divorce and maintenance; and any other matter between immediate family members. **(uncontested divorce covered on Prestige Plus only)**
 - 10.4. Business Matters – that is legal claims that are based on any undertaking to make a profit. The policy covers you in your personal capacity, it is not for businesses. We will however provide a reasonable amount of business advice.
11. Full details of the terms of the policy are contained in the policy document, which will be posted out to you following the payment of your first premium.
